In processing the Application of the founders of Association “BIM ALIJANSA” represented by Kemal Alečković, attorney from Sarajevo, requesting the entry into the Registry of Associations, in accordance with Articles 8 and 33 of the Law on Associations and Foundations of Bosnia and Herzegovina (Official Gazette BiH, 32/01, 42/03, 63/08, 76/11, 94/16) and Article 4 (1) of the Rulebook on Keeping the Registry of Associations and Foundations of BiH and Foreign and International Associations and Foundations as well as other Non-Profit Organizations (Official Gazette BiH, 44/10, 14/12) the Ministry of Justice of Bosnia and Herzegovina hereby enacts

DECISION

1. The following association has been entered in Registry of Associations at the Ministry of Justice of Bosnia and Herzegovina under **registry number 2078** Book I of the Registry on 28 August 2017:
 - a) Udruženje “BIM ALIJANSA”
Udruga “BIM ALIJANSA”
Удружење БИМ АЛИЈАНСА
 - b) The Association also has a name in the English Language_
Association BIM Alliance
2. The seat of the Association is Sarajevo, 1 Skenderpašina St.
3. The Association has a logo.
The logo of the Association consists of three stylised red stripes bent at 45° angle followed by the name Udruženje BIM alijansa in black.
4. The goals and activities of the Association are:
Supporting the initiatives aimed at broadening the base, application and understanding of the use of Building Information Modelling (hereinafter: BIM) in documentation creation processes in all phases of development of construction plans for buildings; promotion of cooperation between three sectors of the society: public administration, business and non-profit sectors on the implementation of projects involving the use of BIM; promoting the cooperation between local authorities and organizations and companies in order to support the popularization of BIM utilization; promoting BIM standards and assumptions to improve the status of Bosnia and Herzegovina in the EU integration process; organizing public advocacy campaigns through public counselling projects about the BIM standards; creation and coordination of projects affirming the knowledge in architecture with the use of BIM and training of organizations and individuals in this field; work on education for the purpose of increasing the number of professionals trained in all levels of BIM use; focusing the work on training programs, initiatives and campaigns for the purpose of promoting BIM principles and methodologies; work on the improvement of communication about BIM use between private and public sectors; establishing scientific and professional cooperation on the international level for the purposes of internationalization of BIM methods and processes of project data creation and management, organizing seminars, conferences, creative workshops and forums for the purpose of implementing the objectives

and activities of the Association; publishing magazines, brochures, books and other publications aiming at the attainment of the Association's goals, for membership purposes in accordance with the Law; experience exchange with the same or similar associations in Bosnia and Herzegovina and abroad.

5. The person authorised to represent the Association is Muhamed Serdarević. Association President.
6. As of registering the Association in the Registry of Association at the Ministry of Justice of Bosnia and Herzegovina, the Association acquires the status of a legal entity and may freely act on the whole territory of Bosnia and Herzegovina solely under its registered name.
7. This Decision will be published in the 'Official Gazette of BiH at the cost of the applicant and on the website of the Ministry.

Explanation

The founders of the Association "BIM ALIJANSA" represented by Kemal Alečković, attorney from Sarajevo, submitted an application for the entry in the Registry of Associations at the Ministry of Justice of Bosnia and Herzegovina on 29 June 2017.

In the course of registration proceedings, the Ministry established that the application was incomplete and that it contained deficiencies and irregularities which made the registration impossible. In its act no. UP09-07-1-1370/17 of 4 August 2017, the Ministry requested application correction and amendment.

Based on the facts ascertained in the proceedings, it has been verified that the conditions prescribed by the Law on Associations and Foundations of Bosnia and Herzegovina and the Rulebook on Keeping the Registry of Associations and Foundations of BiH and Foreign and International Associations and Foundations as well as other Non-Profit Organizations for the entry of Association "BIM

ALIJANSA” in the Registry of Associations at the Ministry of Justice of BiH have been duly met, and it has been decided as stated in the enacting clause of this Decision.

An administrative tax in the amount of BAM 200.00 was paid in accordance with Article 33 (2) a) of the above Rulebook.

Legal remedy:

A complaint against this Decision may not be filed, but an administrative dispute may be initiated before the Court of Bosnia and Herzegovina. The claim is to be submitted at the latest 60 days from the day of receipt of this Decision.
